
Subject: Permanently suspension of issuing Phytosanitary Certificate (PC)

In compliance with the Plant Quarantine Act 2011, it is mandatory to receive Phytosanitary Certificate (PC) for exporters to export of plants and plant products. But the exporters listed below exported fruits and vegetables to EU countries through fake PC or without PC.

2. For the above reasons issuing PC in favour of the following exporters were permanently suspended.
